



Dancing Hearts Adjusted Scale Price Terms and Conditions

When:

10-week sessions of 1-hour weekly classes offered, 10-client minimum, Direct Support Professional staff attend free. Dates, day of week, and time of day TBD.

Price:

\$100 - \$200 adjusted scale price for 10-week session per client, 10-client minimum, Direct Support Professional staff attend free. We understand the need to keep the cost of classes as low as possible for adult clients of an agency to pay, with Direct Support Professional staff attending free. We are offering an adjusted scale price for a 10-week session of weekly classes that comes to **\$10 - \$20 per class per client**, depending on mutual fundraising efforts.

Total Cost of 10-week Dancing Hearts Session:

\$2,000 (minimum cost) for Dancing Hearts 10-week session of weekly 1-hour classes, 10-client minimum, Direct Support Professional staff attend free. We are offering to have a joint fundraiser to meet the difference of the adjusted scale pricing of choice to meet the total cost of \$2,000.

Cost Breakdown with Adjusted Scale Pricing:

\$10/per 1-hour class per client adjusted scale price = \$1,000, 10-client minimum, Direct Support Professional staff attend free. This comes to **\$100/per 10-week session per client** (more than 10 clients, cost per client remains the same). Therefore, we will work together on a fundraising campaign from tax deductible donations to reach **\$1,000** to meet the \$2,000 cost. Full session adjusted scale fee payment made at first class.

\$15/per 1-hour class per client adjusted scale price = \$1,500, 10-client minimum, Direct Support Professional staff attend free. This comes to **\$150/per 10-week session per client** (more than 10 clients, cost per client remains the same). Therefore, we will work together on a fundraising campaign from tax deductible donations to reach **\$500** to meet the \$2,000 cost. Full session adjusted scale fee payment made at first class.

\$20/per 1-hour class per client adjusted scale price = \$2,000, 10-client minimum, Direct Support Professional staff attend free. This comes to **\$200/per 10-week session per client** (more than 10 clients, cost per client remains the same). **No Fundraiser Campaign Necessary**. Full session adjusted scale fee payment made at first class.

Fundraiser Description:

Together we will create a compelling fundraising campaign by vividly describing the purpose of our campaign to raise the adjusted scale price difference as described in the Cost Breakdown above.
